Opportunity to Disseminate Information: The Association will allow any unit owner to disseminate information to all unit owners before the Annual Meeting. Any owners who wish to disseminate information to other unit owners before the Annual meeting may contact the Association in care of its Manager, Gail Kent on or before June 26, 2024 at 4p.m. and notify Ms. Kent in writing their desire. Ms. Kent will then accept from the requested owner a PDF document (the "Document") summarizing or stating the information that the requesting Owner wished to disseminate meeting the following requirements:

- A. It shall identify the Unit Owner on whose behalf the information is disseminated;
- B. It shall bear a date;
- C. It shall be no more than one (1) PDF 8 ½ x 11 page with no attachments;
- D. It shall be no smaller than pt 14 font;
- E. It shall be no smaller than 1.15 line spaced;
- F. Margins will be set to normal;
- G. It shall include an affirmation under the pains of perjury by the Unit Owner on whose behalf the information is disseminated that all of the information contained is accurate, true, complete, omits no material fact for its understanding and is not misleading to the best of their knowledge and belief;
- H. If the document does not conform to the forgoing requirements, the Association will not disseminate electronically.

All owners Document conforming to the above will be electronically sent out simultaneously to all unit owners for or with whom the Association has electronic communication through its billing system. The Documents will be sent out on June 28, 2024.
